POD Seminar, Alison Kellman-Lewis, Orange County Health Care Agency

Alison, assisted by OCHCA staff, presented a very informative and interactive seminar. The overview of PODs (Points of Dispensing) covered topics ranging from medical supplies stored by CDC for disaster response, to directing the flow of traffic at a specific POD site.
